

Purpose

The aim of the Excellence Award is to build a community of the brightest young researchers in the area of global economic affairs.

These researchers are to be given intellectual, financial, and administrative support – based on the Kiel Institute’s generous resources – to pursue focused programs of research in designated areas.

This community of young researchers will have access to senior, reputed economists in their fields of specialization.

The resulting research is meant to constitute contributions to knowledge that are relevant to the policy-making and business circles.

Research Fellowship

The price winners will receive a Research Fellowship at the Kiel Institute, entitling them to a one-month research visit to the Institute, all-expenses-paid, with

- Research support and superb research facilities,
- Research interaction with the Kiel Institute’s researchers and visiting professors and fellows,
- Unlimited access to the German National Library of Economics (the largest economics library in the world), as well as the Institute’s Virtual Research Communities,
- Participation in the Institute’s research events (workshops, seminars, roundtables), and the opportunity to join the Kiel Institute’s research.

Application

Economists up to and including the age of 35 are invited to apply for this award by submitting up to three published or unpublished papers in the area of global economic affairs. These may include co-authored papers.

Submission of the paper does not preclude future publication in the standard outlets.

The precise topics vary from year to year, details can be found at the Excellence Awards Website.

Members of the jury are associated with the Kiel Institute and will select the winners.

Recipients will be granted the “Excellence Awards in Global Economics Affairs” at a ceremony at the Kiel Institute.
